## Terms

1. Fleet Account holders receive a 20% discount on all services, excluding specials and promotions. Services rendered will be billed on a monthly basis. A minimum of \$50 per month will be charged per Fleet Account.
2. Fleet Account payment terms are net 21 days from date of invoice. If account is not paid after 30 days, Royal Palm Car Wash reserves the right to stop use of the account until full payment is received.
3. Royal Palm Car Wash reserves the right to cancel, amend, or change the Fleet Account terms from time to time as it feels necessary. No changes will be made without 45 days prior notice to Fleet Account holders.
4. Fleet Account holders may terminate the account at any time with 30 days prior notice.
5. A Fleet Account card must be presented at the time of the wash in order to receive service. There will be no exceptions. Lost or stolen cards should be reported to Royal Palm Car Wash immediately. Royal Palm Car Wash is not responsible for unauthorized card use. A nominal fee of \$5.00 will be charged for card replacement.
6. Royal Palm Car Wash reserves the right to refuse service to vehicles in unsatisfactory or unsafe conditions. Such conditions include, but are not limited to, ladder racks, pre-existing vehicle damage, excessive dirt or mud (inside or outside).
7. All Fleet Account holders/users agree to abide by the rules and regulations of this agreement and others that may be added from time to time.
8. Any breach or default by the Fleet Account holder or its users shall permit Royal Palm Car Wash to terminate, suspend, or revoke account use.
